RE: Imposition of an Emergency Trusteeship on Local 1740


Dear Brothers and Sisters:

After an investigation and charges filed by ILA General Organizer John D. Baker pursuant to Article XXI of the International Constitution, enclosed, the Executive Council has determined that it is necessary to suspend the officers of Local 1740 and to impose an emergency trusteeship on Local 1740 in accordance with Article XXI, Sections 1 and 2 of the ILA Constitution.

I hereby appoint ILA Atlantic Coast District (ACD) Vice-President Carlos Albertorio as trustee, effective immediately, pending a hearing on the permanence of this trusteeship. During the period of trusteeship all officers, officials and others operating under purported authority of ILA Local 1740 are hereby relieved of their respective duties. All books and records of ILA Local 1740 shall be turned over to ACD Vice-President Albertorio. No money shall be drawn from the account of ILA Local 1740 except upon the approval of ACD Vice-President Albertorio. All local assets, including real property, whether held in trust of by a non-profit or similar entity, shall be subject to ACD Vice-President Albertorio's control.

Local 1740 and the officers and members thereof are hereby directed to cooperate fully with Vice-President Albertorio in order that the purposes of the trusteeship may be fulfilled and the autonomy of ILA Local 1740 restored as soon as possible.
